# Send Requisitions for Section 47 Certificate under BMSMA via InteReq

We have enabled the issuance of Section (47) Certificate under the Building Maintenance Strata Management Act (BMSMA) via InteReq with effect from 1 August 2016.

Law firms are encouraged to use the service to streamline their current workflow and exchanges with managing agents. It is intended to expedite the issuance of S.47 Certificate under BMSMA to law firms within 14 days.

## Key benefits to law firms include:

- One-stop platform to manage all legal requisitions submitted to government agencies and corporations
- Significantly reduces data entry and manual handling of documents related to the requisition
- □ Instant update and e-mail notification when a reply is returned
- Real-time status update on legal requisitions submitted
- Cash-less transactions (Deduction will be via your existing GIRO Account for InteReq)
- One-stop billing and collection and easy retrieval of billing summary reports for reconciliation
- □ 24/7 Helpdesk first line of contact
- Historical data is stored for a period of 3 years for easy download from the date of commencement

Managing agents will <u>only</u> respond accordingly via our Helpdesk to ensure faster and reliable response to law firms.
